RACE 1 AUTO PRO MAIDEN HEAT 1

MDN 520m

Incidents: ANNA'S INTENT (3) and MANIAC MARIAH (9) were slow to begin. ANNA'S INTENT (3) and RED RUSSAN (2) came together soon after start. RED RUSSAN (2), ANNA'S INTENT (3), NORTHERN WARRIOR (4), MANIAC MARIAH (9) and AWESOME WIZOM (7) collided in the run to the first turn. MANIAC MARIAH (9) checked AWESOME WIZOM (7) at the first turn. MAESTRO MAGOO (1) raced wide approaching the catching pen hampering VODKA MARTINI (8). NORTHERN WARRIOR (4) hampered REVALONG LASS (5) at the turn out of the back straight. MANIAC MARIAH (9) raced wide at the home turn and galloped across the heels of VODKA MARTINI (8).

RACE 2 VETSEARCH MIXED FINAL

Incidents: PANDA RULES (2), DYNA CLARA (5) and SAM'S PUP (6) were all slow to begin. GHOST SURFER (3) raced wide in the run to the first turn checking DYNA CLARA (5), SAM'S PUP (6), PAUA TO TERRIFY (9) and OZI TONIC (3) causing GHOST SURFER (3) to stumble and lose ground. PAT'S NEW BOY (1) checked PAUA TO TERRIFY (9) and OZI TONIC (8) at the first turn, where also DYNA CLARA (5) hampered SAM'S PUP (6). DYNA CLARA (5) hampered SAM'S PUP (6) passing the catching pen. DYNA CLARA (5) galloped on the heels of SAM'S PUP (6) at the turn out of the back straight causing DYNA CLARA (5) to lose ground hampering PANDA RULES (2).

RACE 3 TRENT FREEMAN STK**5GD 520m**

Incidents: BILLY THE BULLET (5) checked OVERAWED (4) and DASHING MARIAH (3) soon after start. WATTA GIFT (6) hampered BLITZ HAVOC (2) in the run to the first turn. MARY CHASE (1) checked BLITZ HAVOC (2) and SHEER GRANITE (7) causing MARY CHASE (1) to lose ground checking DASHING MARIAH (3) and BILLY THE BULLET (5). BILLY THE BULLET (5) checked MARY CHASE (1) crossing to the rails passing the catching pen causing MARY CHASE (1) to lose ground. BLITZ HAVOC (2) galloped on the heels of WATTA GIFT (6) at the turn in to the back straight causing both greyhounds to lose ground. BILLY THE BULLET (5) checked OVERAWED (4) at the turn out of the back straight.

Incidents: JOY'S DELIGHT (6) was slow to begin. NICK'S HABIT (4) hampered NOBLE BOND (2) in the run to the first turn, where also DEADLY GRIN (7) raced wide hampering RED HOT SPECIAL (8). OLAY JEWEL (3) checked DEADLY GRIN (7) and RED HOT SPECIAL (8) at the first turn causing OLAY JEWEL (3) to lose ground hampering NOBLE BOND (2). DEADLY GRIN (7) galloped on the heels of NICK'S HABIT (4) passing the catching pen.

RACE 5 HALLUCINATE STK**4/5GD 600m**

Incidents: FRECKLES (3) jumped smartly and led all way. FLAT TRACKER (9), UNLEASH DA BEAST (4) and MISS QUICK RAT (6) were all slow to begin. HEART OF EGYPT (2) and FANTASTIC ANGEL (5) came together in the run to the first turn. UNLEASH DA BEAST (4) galloped on the heels of TUMBLE SPEED (8) at the turn out of the home straight on the first occasion causing UNLEASH DA BEAST (4) to race wide checking MISS QUICK RAT (6). FLAT TRACKER (9) galloped on the heels of STYLISH LAIRD (7) approaching the home turn causing FLAT TRACKER (9) to check FANTASTIC ANGEL (5).

CAREFUL MOVE (8) checked MISCHIEF PETE (7), MAGIC TIANA (6), MON DIEU (5), PEPPER LEE (4) and RAMBLIN' RUBY (3) in the run to the first turn with PEPPER LEE (4) and MON DIEU (5) being the worst affected. MISCHIEF PETE (7) and PORT MALANEY (1) came together at the first turn.

RACE 7 HALLUCINATE STK**5GD 520m**

Incidents: SHARON'S GIRL (1) was slow to begin. ON PAROLE (5) hampered PAUA TO EXCEED (4) and ARIEK PEARL (3) soon after start. ON PAROLE (5) checked PAUA TO EXCEED (4), ARIEK PEARL (3) and SPENT THE RENT (2) in the run to the first turn causing PAUA TO EXCEED (4) and ARIEK PEARL (3) to lose ground. ON PAROLE (5) checked SPENT THE RENT (2) and SHARON'S GIRL (1) crossing to the rails approaching the first turn causing both SPENT THE RENT (2) and SHARON'S GIRL (1) to lose ground. SHARON'S GIRL (1) raced wide at the first turn checking SPENT THE RENT (2). ON PAROLE (5) hampered TOOL TIME (8) in the back straight. ARIEK PEARL (3) raced wide home turn at the PAUA TO EXCEED (4).

RACE 8 WHISKY ASSASSIN AT STUD STK**4/5GD 520m**

Incidents: ASTON BURN (7) Turned in the Boxes and lost ground. MICKA LEE (3) and MISS MARILYN (4) came together soon after start. TAYLOR'S REUNION (2) hampered MICKA LEE (3) and MISS MARILYN (4) in the run to the first turn. CERTAIN MAGIC (1) checked POP ROCKER (5) and WATTA GUY (8) at the first turn causing both POP ROCKER (5) and WATTA GUY (8) to lose ground, where also at the first turn TAYLOR'S REUNION (2) checked MICKA LEE (3) and MAD MAGIC (6). TAYLOR'S REUNION (2) galloped on the heels of MICKA LEE (3) at the turn in to the back straight causing TAYLOR'S REUNION (2) to lose ground. Stewards interviewed connections of ASTON BURN (2) regarding the greyhounds actions in the Starting Boxes. After viewing the video replay and head on footage of this event Stewards informed connections that they believed the greyhound had 'turned in the boxes'. Connections agreed with Stewards. After consideration Stewards ordered the greyhound ASTON BURN (7) complete a Satisfactory Trial in accordance with GAR 52(1) before being nominated for any event.

Incidents: JOHN NUBOND (3) was slow to begin. YOU'LL SEE BOYS (2) raced wide in the run to the first turn checking CHERINA (5) and LOONEY LAD (7). YOU'LL SEE BOYS (2) raced wide at the first turn checking LOONEY LAD (7). CHERINA (5) and YOU'LL SEE BOYS (2) came together passing the catching pen. LOONEY LAD (7) lost ground at the turn out of the back straight and proceeded to tail off. A Veterinary examination of LOONEY LAD (7) revealed an injured back. An Incapacitation Certificate was issued for a period of 42 days commencing 25/6/09 and concluding 5/8/09.

After being examined by the Veterinary Surgeon the greyhound SHILOH SARAH (1) was withdrawn by order of the Stewards acting on veterinary advice in accordance with GAR 46 (1) (g) at 10.25pm due to Seasonal condition. As betting had not commenced no deductions were required.
UNLEASH DE ELITE (6) raced wide soon after start hampering LUCKY ZERO (7) and FEEL THE BURN (8). WATTA WORRY (4) raced wide at the home turn checking UNLEASH DE ELITE (6). WATTA WORRY (4) galloped on the heels of KISS POOKIE (2) in the home straight.
