INCIDENTS: BIG BUBBA DUDLEY(3), SYTLISH LAIRD(7) and ALEXANDER MULWEE(8) were slowly away. BIG BUBBA DUDLEY(3) and STYLISH LAIRD(7) lost ground soon after the start and STYLISH LAIRD(97) tailed off. ASSASSIN JOURNEY(4) raced wide at the turn into the home straight the first time. Veterinary examination of STYLISH LAIRD(7) revealed an injured off hind leg. Incapacitation certificate issued for ten days from 29.6.09. The winner BENJI MAGIC(1) was locked away and a urine specimen to be obtained as a random ballot winner.

Mrs. King explained that both runs were from the (5) box and on each occasion was skilled at the start and lost all chance. The Stewards accepted Mrs. Kings explanation and took no further action as the greyhound was the class greyhound in the event and has now won four from six at W.P.
