INSTRUCTIONS

1. This application must be completed in detail. Every Syndicate member must sign this document personally and give details of their residential address.
2. Before any Syndicate member signs the form they should satisfy themselves that Clause 2 contains the name of the person (being a member of the syndicate) who will be treated as the manager of the syndicate.
3. The person named in Clause 2, in addition to providing particulars relating to them in the body of the form must confirm their nomination under Clause 2 by signing the document in the space provided for this purpose on page 1.
4. Syndicate members, are not required to be registered with the Authority as Owners or Owner-Trainers, in respect of membership of a Syndicate.
5. Any person relinquishing their membership must do so in writing with the authorisation of the Manager.
6. Any person acquiring membership must do so in writing with the authorisation of the Manager.
7. A Corporation cannot be registered as a Syndicate.
8. Syndicate names are restricted to twenty seven (27) characters including spaces.
